A Texas Non-Profit Organization Notes to Financial Statements January 1, 2020 through December 31, 2020

Note 1: Nature of Operations and Summary of Significant Accounting Policies

Nature of Operations

Hope Springs Water is a not-for-profit organization under 501 (c) (3) of the Internal Revenue code whose primary purpose is to partner with communities in countries to provide sources of pure drinking water, sanitation and hygiene education. Hope Springs Water maintains its headquarters in Athens, Texas.

Significant Accounting Policies

The financial statements of Hope Springs Water have been prepared on an accrual basis. Hope Springs Water recognizes contributions of materials only when a fair value can be reasonably estimated and when the materials are used in the normal course of operations and would otherwise have been purchased.

Hope Springs Water is exempt from federal income tax under 501 (c) (3) of the Internal Revenue Code. Generally, when an entity has control over another entity the financials are consolidated. Hope Springs Water (HSW) owns 100% of the common stock of Hope Springs Inc. (HSI). However, the nature of the businesses is materially different as HSW is a 501 (c) (3) not-for-profit and HSI is a for-profit C Corp. The objectives of the operations are significantly different. Therefore, under GAAP, HSW shows different statements than HSI. An example is Net Assets in HSW instead of Stockholder's Equity in HSI. We believe it would be confusing and misleading to the readers of the Financials Statements to attempt to consolidate these GAAP mandated different statements. Even though GAAP would have us consolidate the statements, we prefer to present the equity method of accounting for HSI as we consider this to be the most appropriate presentation of the financial position of HSW. However, for information purposes, consolidated summary statements are disclosed in a following footnote.

Contributions

Under SFAS No. 116, Accounting for Contributions Received and Contributions Made, contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted net assets depending on the absence or existence and nature of any donor restrictions.

PPP Loan Forgiveness

The PPP loan for \$16,500 plus interest expense was forgiven resulting in a gain on extinguishment of debt and interest of \$16,611. This is in accordance with FASB ASC Topic 470.

<u>Cash</u>

The financial institution holding Hope Springs Water cash account is participating in the FDIC's Transaction Account Guarantee Program which insures the cash account up to \$250,000. At December 31, 2020, Hope Springs Water did not exceed the federally insured limit. The Board and Management evaluates their banking relationships routinely to mitigate the risk to bank deposits. \$65,060 of cash was restricted as of 2020 yearend.

Prepaids

Prepaids consist of expenditures to be used primarily for future program and promotional expenditures.

Fixed Assets

Property and Equipment is reported at cost, if purchased, or at estimated fair value at date of gift, if donated. Depreciation is calculated in a straight-line basis over their estimated useful life. Property that is received in Ethiopia is expensed in 2020 because the government retains ownership of all property in Ethiopia.

1000 Shares Hope Springs, Inc.

Hope Springs Water owns all the common stock of Hope Springs, Inc., a for-profit entity. This allows the not-for-profit entity to elect the board members of Hope Springs, Inc. There are no common board members shared by the two entities, and efforts are made to keep the two entities separate. See Related Parties Disclosure below. The net income produced by Hope Springs, Inc., is reported under the equity method of accounting as an equity earnings addition as shown in the following reconciliation:

Hope Springs, Inc. net income is up \$12,698 from the previous year. As reimbursements of the advertising costs are unpredictable, these are recognized on a cash basis.

In July 2020 HSI changed bottling companies. We also added a new line of water called Purified. Costs were lowered. Freight in and Unloading charges are included in the costs. The prior bottling company charged us \$10,193 for preprinted labels to close the account.

Total Sales decreased by \$43,883 from 2019 to 2020. During the second quarter of 2020, we changed suppliers. Label errors and wrong UPC on the new bottles were made by the bottling company which contributed to the lack of sales.

Despite Covid 19 which reduced total water sales and the aforementioned errors which significantly reduced sales in the fall and the previous bottling company printing a year's worth of labels we had to pay for but could not use, we made \$2,501. If you add the overhead of Hope Springs Water shared by Hope Springs, Inc. for the non-profit Water, a total of \$40,391 in overhead was contributed by Hope Springs, Inc.

Other Assets

Well repair kits represent the parts necessary to recomplete non-functioning water wells in Belize and Ethiopia. The kits are expensed as used to complete and refurbish water wells during the year, except for the kits in Ethiopia which are expensed because the government in Ethiopia retains ownership of all in-country assets.

Liabilities and Net Assets

Hope Springs Water is not liable for any contractual arrangements, liabilities or contingent liabilities of Hope Springs, Inc.

Hope Springs Water has 3 full time employees and 1 part time on HSW and is assisted by volunteers. Based on employee's time spent on Hope Springs Water, Hope Springs, Inc. was billed for the estimated time they spent working on Hope Springs, Inc. Hope Springs Inc. will reimburse Hope Springs Water for their portion of shared expenses, in the amount of \$40,391 during 2020.

Contingent Liabilities

Hope Springs Water is not aware of any contingent liabilities.

Deferred Revenue

Deferred revenue consists of designated contributions to be utilized for future program expenditures.

Water Well Projects and WaSH

The leadership team at Hope Springs Water has taken this time to become more focused and intentional with work in our WaSH Zones, and to focus on the sale of our bottled water in order to further our mission. We established new WaSH Zones in Kenya and the Colonias along the Texas-Mexico border. We have been able to drill six new water wells in Ethiopia, one well in our new Kenyan WaSH Zone, with three more funded and planned to be drilled during December 2020 in schools in central Ethiopia. Our Central American team has also reclaimed and repaired three wells in Belize. This will total 13 completed water projects in 2020. These projects will provide safe drinking water to more than 4000 people living in the areas we serve.

Our Women's Menstrual Hygiene teams have provided education and reusable menstrual management kits to 774 women in these regions. This project allows girls, who currently have no source of menstrual management products, to remain in school during their menstrual cycle, effectively giving them an additional 180 days of school attendance. Many girls even drop out of school due to their falling so far behind from unavoidable monthly absences. This project is critical to the continued development of these areas.

In July, Hope Springs Water provided malaria vaccines and physical exams for more than 400 orphans in Kenya. Then later this year, during an epidemic, we were blessed to be able to provide medical treatment to the children suffering from Typhoid fever and vaccinate them to prevent infections altogether. At the same time, Hope Springs Water funded the drilling of a new well at an orphanage in Bungoma, Kenya, that will provide safe water to the children and staff as well as their surrounding neighbors. Our leadership traveled to the Texas Rio Grande Valley and into Matamoros, Mexico, where we discovered significant needs for safe drinking water. We have partnered with Hearts4Kids to help provide safe drinking water and menstrual management kits to the thousands of people living along the border. We plan to spend \$40,000 over the next twelve months to meet this need.

Hurricane season not only caused problems along the south Texas border with Mexico, but also for our partners in Nicaragua. Two major hurricanes battered their region within two weeks of each other, destroying their wells and other sources of drinking water, and cutting them off from other parts of the country. We provided \$10,000 towards emergency supplies for water, sanitation, and cleaning to those caught in this natural disaster.

Related Party Disclosure

During 2020, Hope Springs, Inc. paid Hope Springs Water for shared employee expense. The total staff expense included payroll, payroll taxes, telephone and internet, and insurance were allocated based on the time spent on each entity.

Hope Springs Water purchased water from Hope Springs, Inc. in the amount of \$3,060.50. This water was used primarily to provide drinking water in support of HSW Relief activities on our border and for promotion and marketing purposes. A Director of Hope Springs, Inc. contributed \$3,500 to Hearts4Kids which Hearts4Kids used to purchase water from Hope Springs, Inc. The purchase price was approved by executive management.

As of December 31, 2020, Debbie and Jimmy Leatherwood are married and serve on the non-profit board. Stephen Akin and Matthew Akin are father and son. Stephen serves on the non-profit board and Matthew serves on the for-profit board. Bliss Nelson and Daniel Nelson are married. Bliss is the Executive Director of Hope Springs Water and Daniel serves on the for-profit board and is the President of Hope Springs, Inc. A key employee, Colleen Nelson, is a sister of Daniel Nelson, President of Hope Springs, Inc. and sister-in-law of Bliss Nelson, Executive Director of Hope Springs Water and a key employee. Frank Tindle and Janet Tindle are married. Frank is Treasurer and a Director of Hope Springs Water and Janet serves on the for-profit board. Eddy Dark and Amy Dark are married. Eddy serves on the non-profit and Amy serves on the for-profit. Kenneth McGee is a Director of Hope Springs, Inc. and he is a Director of First State Bank of Athens, where Hope Springs Water does its banking, which was approved by the Board of Directors.

Non-Discrimination Clause

Employment with Hope Springs Water and access to its programs or activities or funding opportunities shall not be limited on the basis of race, color, creed, national origin, religion, age, gender, sexual orientation, political affiliation, or disability.

Subsequent events

Hope Springs Water filed IRS Form 990 for the year ended December 31, 2020. A copy of prior Form 990 can be viewed on our website, www.hopespringswater.org.

During 2020, the Covid-19 virus has prohibited travel. As of now, Hope Springs Water does not know when teams will be able to travel and assist in drilling programs and the WaSH program and hold fund raising events.
